We would like to point out that the employer is required to immediately notify the tax authorities/Central coordination centre in writing in case of revocation of the appointment and/or departure of the appointed person from the company (Section 28a Para. 4 of the Law on the Employment of Foreign Nationals).

The mandatory declaration of consent, which includes the signature of the responsible representative **and** the employer or the bodies of the company responsible for external representation must be attached to the appointment. A submission without a signed declaration of consent is not legally valid!
